The researcher will join an international multi- and interdisciplinary team and will work on the development of innovative bone grafts by means of 3D printing and bioprinting, the osteogenic differentiation capacity of appropriate cell populations, the mechanical properties of composite biomaterials and scaffolds, their in vitro biocompatibility evaluation.
