Post-Doctoral positions for the analytical and numerical study of wave propagation and transport in complex non-Hermitian systems.

The applicants will simulate the wave propagation in complex random systems combining gain and loss, such as layers of gain-loss spheres, cylinders and ellipsoids. For the study of such systems full wave simulation approaches are required and should be combined with analytical or semi-analytical effective medium models.
